

CAT PUMPS LIMITED WARRANTY

CAT PUMPS warrants that the following products will be free from defects in material and workmanship for the time period provided:

- **TWO YEARS** from the date of sale for Direct-Drive Pressure Washer Pumps, including the 2DX, 3DX, 3DNX, 3SP, 3SPX and 66DX.
- **FIVE YEARS** from the date of sale for Car Wash Pumps, including all models used in car wash or portable fresh water pressure cleaning applications.
- **SIX MONTHS** from the date of sale for .9000 Rebuilt Pumps.
- **90 DAYS** from the date of sale for accessories such as, but not limited to, regulators, unloaders, relief valves and pulsation dampeners.
- **LIFETIME** from the date of sale for car wash pumps using the W770 and S Manifold Head against washout or freezing of the original pump head.
- **ONE YEAR** from the date of sale for all industrial pumps not identified above.

CAT PUMPS will repair or replace (in its sole discretion) the products subject to this limited warranty that CAT PUMPS verifies as having defects in original materials or workmanship. **REPAIR OR REPLACEMENT IS THE SOLE AND EXCLUSIVE REMEDY AVAILABLE UNDER THIS LIMITED WARRANTY.** The CAT PUMPS limited warranty is conditioned upon the prepaid return of the product claimed to be defective per CAT PUMPS RGA Policy. For RGA policy details contact CAT PUMPS. The repaired or replacement products will be returned to the original purchaser transportation pre-paid. If inspection of the product does not disclose any defect in materials or workmanship, you will be notified for approval of any repairs that may include cost of parts, labor, and transportation or the cost of a replacement product. **Any repaired or replacement products provided under this limited warranty will be subject to the warranty period applicable to the original product and no additional warranty is provided.**

This limited warranty applies only when the products are installed, operated and maintained in accordance with the applicable CAT PUMPS' written Pump Service Manual, Data Sheets (available on-line at <http://www.catpumps.com/data-sheets-service-manuals-brochures-tech-bulletins-dvd-pumps.html>) and Cautions and Warnings (available on-line at www.catpumps.com/cautions-warnings). **CAT PUMPS makes no warranty on standard wear items such as, but not limited to, seals, valves, seats, o-rings, cups, sleeves, cylinders and bladders.** This warranty does not cover, and CAT PUMPS shall not be liable for improper or lack of maintenance, lack of proper crankcase lubrication, failure to supply adequate liquid to pump, general wear and tear, or any malfunction, damage or wear caused by faulty installation, misapplication, misuse, accident, excessive abrasion, corrosion, freezing or heat, tampering, substitution of genuine CAT PUMPS parts, or disassembly and/or repairs not performed by CAT PUMPS. This warranty also does not cover, and CAT PUMPS shall not be liable for any malfunction, damage or wear caused by the incompatibility of CAT PUMPS' products with structures, accessories, products or materials not supplied by CAT PUMPS.
